

ORDINANCE

AN ORDINANCE relating to an additional appropriation of funds for budget items:

1. 4-A-3, Sheriff Fee
2. 70-C-7D, Public Defender Fund
3. 45-G, City-County Ambulance

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF MADISON, COMMONWEALTH OF KENTUCKY:

I. WHEREAS, the 1978-1979 Budget of Madison County by Item Number 4-A-3 appropriates \$3,000.00 to the Sheriff Fee and

WHEREAS, the 1978-1979 need for the Sheriff Fee has been determined to be \$8,000.00,

The budget Item Number 4-A-3, Sheriff Fee, is hereby increased \$5,000.00 to \$8,000.00 with a corresponding adjustment to be made Item 70, Miscellaneous and Reserve.

II. WHEREAS, the 1978-1979 budget of Madison County by Item Number 70-C-7D appropriates \$17,000.00 to the Public Defender Fund and

WHEREAS, the 1978-1979 need for the Public Defender Fund has been determined to be \$20,000.00,

The budget Item Number 70-C-7D, Public Defender Fund, is hereby increased \$2,900.00 to \$20,000.00 with a corresponding adjustment to be made in the General Fund, Surplus.

III. WHEREAS, the 1978-1979 budget of Madison County by Item Number 45-G appropriates \$92,815.00 to the City-County Ambulance and

WHEREAS, the 1978-1979 need for the City-County Ambulance has been determined to be \$95,815.00,

The budget Item Number 45-G, City-County Ambulance, is hereby increased \$3,000.00 to \$95,815.00 with a corresponding adjustment to be made in the General Fund, Surplus.

ORDINANCE

AN ORDINANCE amending ordinance 79-4 and transferring additional funds.

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF MADISON, COMMONWEALTH OF KENTUCKY:

Item #1. WHEREAS, the 1978-79 budget of Madison County Item Number 4-A-3 appropriates \$3,000.00 to the Sheriff Fee and
WHEREAS, the 1978-79 need for the Sheriff Fee has been determined to be \$3,800.00.

The budget Item Number 4-A-3, Sheriff Fee, is hereby increased \$800.00 to \$3,800.00 with a corresponding adjustment to be made Item 70, Miscellaneous and Reserve.

Item #2. WHEREAS, there are not sufficient funds to maintain the dog pound which the County is required by statute to maintain and
WHEREAS, the sum of \$7,815.98 is needed to adequately maintain this dog pound.

The budget item 33-C-7 is increased and the funds are to be taken from the General Fund Surplus. This additional amount will complete the County's payment for this fiscal period.
