

ORDINANCE NUMBER: 79-7

AN ORDINANCE RELATING TO THE ANNUAL BUDGET AND APPROPRIATIONS.

WHEREAS, a proposed use hearing was held on the 9<sup>th</sup> day of April, 1979; and

WHEREAS, a public hearing was held on the proposed budget showing estimated receipts of \$ 1,488,173.00 and estimated expenditures of \$ 1,487,743.00 on the 1 day of May, 1979; and

WHEREAS, the proposed budget was approved by the Budget Commission on 6<sup>th</sup> day of June, 1979, tentatively approved by the Fiscal Court on 19<sup>th</sup> day of June, 1979, and approved as to form and classification by the State Local Finance Officer on the 18th day of June, 1979.

NOW THEREFORE IT IS ORDAINED BY THE FISCAL COURT OF MADISON COUNTY, KENTUCKY:

SECTION ONE: The following budget is adopted for the fiscal year 1979-1980 and the amounts stated are appropriated for the purposes indicated.
