

ORDINANCE # 80-2

AN ORDINANCE RELATING TO THE ANNUAL BUDGET AND APPROPRIATIONS

WHEREAS, a proposed use hearing was held on the Ninth day of April, 1980; and

WHEREAS, a public hearing was held on the proposed budget showing estimated receipts of \$ 1,902,434 and estimated expenditures of \$ 1, 902,434 on the Fifteenth day of May, 1980; and

WHEREAS, the proposed budget was approved by the Budget Commission on the Fifteenth day of May, 1980, and tentatively approved by the Fiscal Court on the Sixth day of June, 1980, and approved as to form and classification by the State Local Finance Officer on the Twelfth day of June, 1980.

NOW THEREFORE IT IS ORDAINED BY THE FISCAL COURT OF MADISON COUNTY, KENTUCKY:

SECTION ONE: The following budget is adopted for the fiscal year 1980-1981 and the amounts stated are appropriated for the purposes indicated.
