

ORDINANCE NUMBER # 81-5

AN ORDINANCE RELATING TO THE ANNUAL BUDGET AND APPROPRIATIONS.

WHEREAS, a proposed use hearing was held on the 9th day of April, 1981 and,

WHEREAS, a public hearing was held on the proposed budget showing estimated receipts of \$ 1,859,871 and estimated expenditures of \$ 1,859,871 on the 23rd day of May, 1981; and

WHEREAS, the proposed budget was tentatively approved by the Fiscal Court on 16th day of June, 1981, and approved as to form and classification by the State Local Finance Officer on the        day of June, 1981.

NOW THEREFORE IT IS ORDAINED BY THE FISCAL COURT OF MADISON COUNTY, KENTUCKY:
