

AN ORDINANCE RELATING TO THE RENAMING
OF ROADS IN MADISON COUNTY, KENTUCKY

BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF MADISON,
COMMONWEALTH OF KENTUCKY that the names of the following roads
located in Madison County, Kentucky have been changed as
described below:


- (a) Pilot Knob Church Road #1 shall be named Pilot Knob
Cemetary Road;
- (b) Pilot Knob Church Road #2 shall be named Pilot Knob Road;
- (c) Bobtown Road shall be named Smith Lane;
- (d) Dog Walk Road shall be named Kindred Lane;
- (e) Barker Lane shall be named East Barker Lane and West
Barker Lane and Barker Lane South;
- (f) Cedar Cliff Road @ Dreyfus shall be named Cedar Cliff
South;
- (g) Mouth of Jacks Creek shall be named Kentucky River Road;
- (h) Valley View Road shall be named Carvers Ferry Road;
- (i) Newby-Silver Creek Road shall be named Newby Road;
- (j) Jackson Branch Road shall be named Kanatzar Lane;
- (k) Boone Trail (behind Westinghouse) shall be named Third
Street Lane;
- (l) Bear's Den Subdivision shall be named Western Hills
Subdivision;
- (m) Moberly Road #2 shall be named Todd Lane;
- (n) Black Road @ College Hill shall be named Black Road
North;

- (o) McCord Lane to Industry Road;
- (p) Old Irvine Road #1 shall be named Catalpa Loop;
Old Irvine Road #2 shall be named Robbinsville Loop;
Old Irvine Road #3 shall be named Old Ky #52;
Old Irvine Road #4 shall be named Waco Loop;
* Old Irvine Road #5 shall be named Bybee Loop;
- (q) Airport Road shall be named Greens Crossing Road;
- (r) Sand Ridge @ College shall be named Sand Ridge East;
- (s) Dunbar Branch @ Doylesville shall be named Weddle's Mill Road;
- (t) Dunbar Branch @ Black Road shall be named Dunbar Branch West;
- (u) Brookstown Road @ Four Mile Road shall be named Runyon Grove Road;
- (v) South Fork Otter Creek shall be named Campbell Branch Road;
- (w) Cedar Cliff Bark Road shall be named Bark Road;
- (x) Pilot Knob Road shall be named Pine Woods Road;
- (y) Edenton Kentucky River Road shall be named Poosey Ridge Road.


