

ORDINANCE NO. 04-35

AN ORDINANCE OF THE MADISON COUNTY FISCAL COURT ESTABLISHING SEWERAGE RATES FOR GREENS CROSSING COMMERCIAL CUSTOMERS OF THE NORTHERN MADISON COUNTY SANITATION DISTRICT

WHEREAS, the Board of Commissioners for the Northern Madison County Sanitation District has heretofore established sewerage rates to be charged to the various customers of the District; and

WHEREAS, the Madison County Fiscal Court has heretofore by Ordinance approved of and adopted the rates so established; and

WHEREAS, the rates so established do not differentiate between commercial and non-commercial customers of the District's Greens Crossing system and the Board of Commissioners for the District has submitted to the Fiscal Court its resolution establishing sewerage rates for the commercial customers of the District's Greens Crossing system; and

WHEREAS, the Madison County Fiscal Court has reviewed such resolution of the Board for the District and the commercial rates therein set forth and does find such rates to be reasonable and necessary;

NOW, THEREFORE, be it duly ordained that the sewerage rate applicable to commercial customers of the District's Greens Crossing system shall be as follows:

SECTION I

Minimum monthly bill:	\$25.00 per first 280 cubic feet
Excess over 280 cubic feet:	\$2.58 per 100 cubic feet

SECTION II

The rate hereby established shall be effective commencing with the month of August, 2004.

SECTION III

This Ordinance shall be effective immediately upon passage and publication in accordance with the provisions of applicable Kentucky law.



**RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE NORTHERN  
MADISON COUNTY SANITATION DISTRICT ESTABLISHING SEWERAGE RATES  
FOR COMMERCIAL CUSTOMERS OF THE DISTRICT'S GREENS CROSSING  
SYSTEM**

**WHEREAS**, the Board of Commissioners for the Northern Madison County Sanitation District has heretofore established sewerage rates to be charged to the various customers of the District; and

**WHEREAS**, the rates so established do not differentiate between commercial and non-commercial customers of the District's Greens Crossing system and the Board does deem it necessary and appropriate that a rate be established for the commercial customers of the Greens Crossing system;

**NOW, THEREFORE**, be it duly resolved that the sewerage rate applicable to commercial customers of the District's Greens Crossing system shall be as follows:

**SECTION I**

Minimum monthly bill:	\$25.00 per first 280 cubic feet
Excess over 280 cubic feet:	\$2.58 per 100 cubic feet

**SECTION II**

The rate hereby established shall be effective commencing with the first calendar month following approval thereof by the Madison Fiscal Court.
