

ORDINANCE NO. 05-11
AMENDMENT TO ORDINANCE #01-04,

AN ORDINANCE AMENDING ORDINANCE #01-04: AN ORDINANCE RELATING TO THE CONTROL AND REGULATION OF THE CANINE POPULATION IN MADISON COUNTY, KENTUCKY.

BE IT ORDAINED BY THE FISCAL COURT OF MADISON COUNTY, COMMONWEALTH OF KENTUCKY:

WHEREAS, Madison County, Kentucky has previously adopted ordinance No. 01-04, pertaining to the regulation of the canine population in Madison County, and;

WHEREAS, that ordinance establishes various fees relative to licensing canines, and;

WHEREAS, it has become necessary to amend the amounts of those fees;

NOW, THEREFORE, be it ordained by the Fiscal Court of the County of Madison: that section 100 and 200 of Ordinance No. 01-04 are hereby amended as shown as follows:

**SECTION 100: REGISTRATION OF DOGS REQUIRED FEE:
DURATION OF LICENSE:**

Paragraph 102: The license fee shall be three dollars (\$3.00) and it shall cover a period from July 1 to June 30, or any part thereof. This fee is due and payable on the first day of July each year, or on the first day of the month following acquisition of the dog.

SECTION 300: KENNEL LICENSE REQUIRED:

Paragraph 301: A kennel license may be issued in any unincorporated area of Madison County. The license fee shall be ten dollars (\$10.00) to keep ten dogs or less, and an additional dollar (\$1.00) per canine for each dog kept over ten (10).

Note: All Other Reference to the license fee in this Ordinance Shall be also three dollars (\$3.00).

THIS ORDINANCE NO. 05-11 SHALL BECOME EFFECTIVE ON THE DATE OF THE SECOND READING AND ADOPTION.
