

ORDINANCE 05-19

**AN ORDINANCE REALTING TO THE APPROVAL OF A REVISION OF
SEWER RATES FOR THE NORTHERN MADISON COUNTY
SANITATION DISTRICT**

WHEREAS, the Madison County Fiscal Court has received a Resolution from the Northern Madison County Sanitation District for the revision of rates for the following Districts: Greens Crossing Residential Customers, Greens Crossing Commercial Rate, Madison Village Customers, Boones Trace Customers, Shiloh Point Customers and the "Exit 95" Truckstop Customers; and

WHEREAS, the Madison County Fiscal Court has reviewed the changes proposed by the Northern Madison County Sanitation District and has made public this ordinance with the required public notification.

NOW THEREFORE, the following resolution is ordained by the Madison County Fiscal Court of the County of Madison.

WHEREAS, the Board of Commissioners recommended a rate increase to cover expense and maintenance of the systems: and

Next 322 cubic feet	\$29.50
Next 401 cubic feet	\$32.25
Next 668 cubic feet	\$34.75
All over 1671 cubic feet	\$37.50

GREENS CROSSING COMMERCIAL RATE

Minimum monthly bill \$26.75 first 280 cubic feet
Excess Over 280 cubic feet \$2.90 per 100 cubic feet

Flat rate \$30.00

BOONES TRACE CUSTOMERS

Flat rate \$35.00

BATTLEFIELD EST ATE CUSTOMERS
