

ORDINANCE NO. 10-04

AN ORDINANCE RELATING TO THE ADOPTION 2010 COMPREHENSIVE PLAN FOR MADISON COUNTY, KENTUCKY IN ACCORDANCE WITH KRS CHAPTER 100.

Be it ordained by the Fiscal Court of Madison County, as follows:

WHEREAS, KRS 100.183, requires the planning commission of each planning unit shall prepare a comprehensive plan; and

WHEREAS, the purpose of this ordinance is to amend previously adopted Comprehensive Plan 2005 edition; and

WHEREAS, the Madison County Planning Commission held properly advertised public hearings for public comment; and

WHEREAS, The Madison County Planning Commission held a Public Hearing on March 02, 2010 for the purpose of making recommendation to the Madison Fiscal Court for the adoption of the 2010 Comprehensive Plan; and

WHEREAS, The Planning Commission voted 6-yes and 1 member absent (Shannon Pennington) to approve the 2010 Comprehensive Plan as presented with recommendation to the Fiscal Court for adoption;

NOW, THEREFORE, BE IT ORDAINED by the Fiscal Court of Madison County, Commonwealth of Kentucky;

SECTION 1. Adoption of the 2010 Madison County Comprehensive Plan for Madison County, Kentucky

That the 2010 Comprehensive Plan as promulgated in KRS 100.183 as presented by the Madison County Office of Planning is hereby adopted;

That a copy of said 2010 Comprehensive Plan, is on file in the office of the Madison County Clerk, and shall at all times be kept by the Clerk;

SECTION 6. Effective Date.

That, this ordinance shall take effect and be in full force when passed published and recorded according to law.
