

**AN ORDINANCE PROHIBITING
SOLICITATION OF CONTRIBUTIONS
ON ANY PUBLIC RIGHT OF WAY WITHIN THE
UNINCORPORATED TERRITORY OF MADISON COUNTY**

ORDINANCE # 13- 06

WHEREAS, the Madison County Fiscal Court has determined that the practice of selling products, offering services, or soliciting funds from persons in vehicles using the streets and roadways in Madison County creates traffic hazards and delays; and

WHEREAS, such activity typically occurs at busy intersections but may involve hazards and delays at any location along any street throughout the County; and

WHEREAS, any distraction or delay along public streets may interfere with traffic planning; and

WHEREAS, the purpose of this ordinance is to eliminate that source of hazard and delay;

NOW, THEREFORE BE IT ORDAINED BY THE MADISON COUNTY FISCAL COURT, COMMONWEALTH OF KENTUCKY, AS FOLLOWS:

Prohibited Acts

- (A) No person shall stand, sit, or remain on or in any public right-of-way, or on or in any public street, sidewalk, or highway in the unincorporated territory of Madison County for the purpose of soliciting contributions of any kind from the drivers or passengers of vehicles using the street; provided, however, this provision shall not prohibit a purely charitable organization from using right-of-way (but not streets or roadways) to give notice of off-street activities.
- (B) Any person, firm, or corporation violating any provision of this section shall be cited to the Madison District Court and fined not less than \$25.00 and not more than \$500.00 for each offense, and a separate offense shall be deemed committed on each day during or which a violation occurs or continues.

All ordinance or parts of ordinances in conflict herewith are hereby repealed.

THIS ORDINANCE NO. 13-06 SHALL BECOME EFFECTIVE ON THE DATE OF THE SECOND READING AND ADOPTION.


