

**MADISON COUNTY, KENTUCKY FISCAL COURT
ORDINANCE NO. 16-03**

AMENDMENT TO ORDINANCE NO. 04-03, AN ORDINANCE REGULATING THE PRESERVATION OF INACTIVE AND PRIVATE CEMETERIES IN THE UNINCORPORATED AREAS OF MADISON COUNTY, KENTUCKY.

WHEREAS, the Madison County Fiscal Court adopted Ordinance No. 04-03, which provided authorizing the preservation of inactive and family cemeteries in the unincorporated areas of Madison County, Kentucky, and

WHEREAS, said Ordinance established a county cemetery board, and

WHEREAS, the sole purpose of the board was to seek grants from the department of local governments for maintenance and restoration of non-profit cemeteries, and

WHEREAS, the department no longer funds those grants,

NOW, THEREFORE BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF MADISON, COMMONWEALTH OF KENTUCKY, AS FOLLOWS:

- 1. The County Cemetery Board as established in Section IV of Ordinance No. 04-03, is hereby abolished.
- 2. All remaining provisions of Ordinance No. 04-03, continue in full force and effect.

THIS ORDINANCE SHALL BECOME EFFECTIVE ON THE DATE OF THE SECOND READING AND ADOPTION.
