AMENDMENT TO ORDINANCE # 00-32

**AN ORDINANCE AMENDING ORDINANCE NO. 00-32 :
AN ORDINANCE RELATING TO THE MADISON COUNTY,
KENTUCKY DETENTION CENTER FEE SCHEDULE.**

WHEREAS, Madison County, Kentucky has previously adopted ordinance No. 00-32, pertaining to the Madison County Detention Center Fee Schedule, and;

WHEREAS, that ordinance establishes various fees relative to the housing and providing of the detention center's detainees, and;

WHEREAS, it has become necessary to amend the amounts of those fees;

NOW, THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF THE COUNTY OF MADISON, COMMONWEALTH OF KENTUCKY AS FOLLOWS:

1. The fees reflected on the attached schedule to Ordinance 00-32, are hereby amended as follows:

Booking Fee	\$50.00
Per Diem	\$ 2.00
Jail Bond Fee	\$ 5.00
Sick Call (Nurse)	\$15.00
Sick Call (Doctor)	\$35.00
Sick Call (Emergency)	\$25.00
X-Ray	\$75.00
Medication	\$ 4.00
RX Handling	\$ 4.00
Psych Nurse	\$35.00
Weekender	\$20.00/day
Work Release	\$20.00/day

2. All remaining provisions of Ordinance 00-32, continue in full force and effect.
